Phil sent out last year's C2K Annual Meeting Notes dated June 25, 2016 notes and Draft Budget 2017-2018.

- 1. Last years Annual Meeting Notes were reviewed.

- 4. New Business: Phil wants to set up the fund raising resource for the new development. Phil will talk with Monique when he is visiting with her. Phil will set up a phone call with a core fund raising group after the 4th of July holiday. The goal is \$500 thousand.

The program has needs that the present space does not meet. The existing space has many limitations including just basic access. There are a couple potential large donors that may put up a \$150 thousand matching funds for this effort.

Brenda is a new part time mentor specialist who will be joining Lois and Latonya. Paper work on her will be submitted a week or 2 prior to the next program start which is the 11th or 12th of August.

5. Closing Prayer: Seth closed in prayer.

They are going into deep and uncharted waters on multi-ethnic church. Seth has stepped down from his campus pastor role to be a part of this new church. Pray for this effort.
